ACTION MINUTES

- 1) <u>Call to Order</u>: The meeting was called to order by Commission Chair Gordon Purdy at 1:32p.m in the Chambers of the Sacramento County Board of Supervisors
- 2) <u>Pledge of Allegiance</u>: Chair Purdy led the Pledge of Allegiance.
- 3) Roll Call and Declaration of a Quorum: Roll was called by Civil Service Specialist Jeanette King, and it was noted that Commissioners Patricia Macht, Bruce Nelson, and Ron Suter were present along with Chair Gordon Purdy and Vice Chair Michael Johnson. A quorum was announced.

Chair Purdy welcomed Commissioner Macht and invited Executive Officer Alice Dowdin Calvillo to say a few words about the recently appointed Commissioner. Commissioner Macht thanked the Commission and its staff for their welcome and said that she looks forward to the work ahead.

Executive Officer Dowdin Calvillo then announced that due to the Appellant withdrawing his appeal, Item 8 A (Appeal Hearing: Release from Probation (Civil Service Rule Section 12): Appeal No. 5950-13) was hereby removed from today's agenda. There was no objection.

In addition, there was some discussion about giving possible future consideration to the lengthening of eligibility lists. Executive Officer Dowdin Calvillo committed to work with DPS to further flush out this issue and, if necessary, schedule DPS to report back to the Commission at a future date.

Motion by Commissioner Johnson and seconded by Commissioner Suter to accept and file the reports listed in Items 5 B and 5 C. The motion was adopted unanimously.

This study is a high priority for the County Executive Office. In addition, DPS may be ready to bring back the Human Services Supervisor – Master's Degree class specification for reconsideration at this meeting. She also stated that she will include a closed session item on that agenda to allow the Commission to conduct its six month review of her job performance.

There being no further business before the Commission, Commissioner Nelson moved to adjourn the meeting. Commissioner Suter seconded the motion, and it was adopted unanimously. Chair Purdy then adjourned the meeting at 3:07 p.m.
