# ADOPTED ACTION MINUTES

**LOCATION:** Sacramento County Board of Supervisors' Chambers<sup>1</sup> 700 H Street, Sacramento, California 95814

#### PROCEDURAL MATTERS

- 1) <u>Call to Order</u>: The meeting was called to order by Commission Chair Patricia Macht at 1:31 pm in the Chambers of the Sacramento County Board of Supervisors.

## **Upcoming Meetings**

Executive Officer Dowdin Calvillo reported that the class study for the Firefighter, Airport Rescue and Firefighting series that was tentatively scheduled for Commission consideration and approval at the October 24, 2014 meeting has been pulled by the Department of Personnel Services and tentatively re-scheduled for Commission consideration at its November 7, 2014 meeting. Therefore, as there are no other items for scheduled for consideration at the October 24 meeting, it will be canceled.

She also told Commissioners that there may be one exam disqualification appeal hearing scheduled for hearing at the November 7 meeting in addition to the approval of contracts for hearing officer services and court reported services, and the approval of the class study for the Firefighter, Airport Rescue and Firefighting series as discussed previously.

Lastly, she reported that there will likely be one or two exam disqualification appeals set for hearing at the Commission's November 21, 2014 meeting, and that the December 5, 2014 meeting would be canceled as she will be out of State that week.

## **Appeals**

The Commission received four exam disqualification appeals, one late exam application appeal, and one release from probation appeal this week.

Currently, there are nine formal release from probation appeals, five exam appeals, two allocation appeals, one psychological disqualification appeal, and one medical disqualification appeal pending before the Commission. They are all in various stages of the appeal process.
