12) <u>Executive Officer's Report</u>: This was a verbal presentation to the Commission

Executive Officer Dowdin Calvillo reported that the next Commission meeting will be on August 12, and that there would be at least one psychological disqualification appeal hearing and one exam disqualification appeal hearing. In addition, she has scheduled consideration of two classification studies: Chief Building Official and Neighborhood Services Area Manager for Commission consideration. She noted that this will be the only meeting during the month of August. The next meeting after August will be on September 9.

She also informed Commissioners that she received two new exam disqualification appeals this week and closed two failed drug test appeals as they were not within the Commission's jurisdiction. She said that there are currently seven releases from probation, four allocations, four exam disqualifications and three psychological appeals pending before the Commission.

Lastly, Executive Officer Dowdin Calvillo reported that she had completed and submitted budget documentation in support of the Board of Supervisors' September budget hearings.
