# ADOPTED ACTION MINUTES

Executive Officer Alice Dowdin Calvillo read the following into the record: "In compliance with directives of the County, State, and Centers for Disease Control and Prevention, this meeting was streamed live and closed to the public. Members of the public were encouraged to participate in the meeting by submitting written comments electronically."

#### **PROCEDURAL MATTERS**

- 1) <u>Call to Order</u>: The meeting was called to order by the Commission Chair Mike Johnson at 1:31 on Friday, November 5, 2021.
- 2) Roll Call and Declaration of a Quorum: Roll was called by Commission Clerk Gina Volpi, and it was noted that Commissioners Nick Bloise, Mike Johnson, Ron Suter, and Commissioner Bruce Nelson were present A quorum was declared.

Executive Officer Dowdin Calvillo reported that the Commission's next meeting will be November 19, 2021. Commissioners are scheduled to consider changes to the County's Classification Plan stemming from the 2021 Sheriff Series class study. This meeting will be conducted via Zoom.

The December 17 meeting, she reported, will be conducted in person so that Commissioners can hear two release from probation appeals in closed session. No class studies or other reports that require DPS staff attendance will be scheduled as is consistent with recent recommendations by the County's Health Officer. Commissioners will social distance and are asked to wear a mask inside the Board Chambers.

Dowdin Calvillo informed Commissioners that she received two exam disqualifications and one request to appeal a failed psychological evaluation this week. One Exam Disqualification appeal was rejected as it was later learned that the Appellant was actually admitted to the exam several months ago and was placed in the first rank on the applicable eligibility list. She reported that the failed psychological evaluation appeal was rejected as it was not filed timely.

Currently, there are four releases from probation, one allocation, and one exam disqualification appeal pending before the Commission.

Dowdin Calvillo told Commissioners that she submitted to DPS initial comments on the Emergency Medical Services series class study this week.

Lastly, she reported that on November 2, 2021, the Board of Supervisors concurred in the County's CEO's appointment of Dr. Sylvester Fadal as Director of DPS, effective December 13, 2021. Dr. Fadal was an external candidate coming from Santa Clara Valley Transportation Authority where he last served as Chief Administrative Officer.

Hearing no further business before the Commission, motion by Commissioner Nelson, seconded by Commissioner Bloise to adjourn the meeting. Motion was adopted unanimously (4 to 0) and the meeting was adjourned at 2:04 pm.
