# ADOPTED ACTION MINUTES

ACTION: Motion by Commissioner Nelson, seconded by Commissioner Bloise, to adopt the Executive Officer's recommendations to, pursuant to the recommendations stemming from the 2020 Construction Labor Compliance Series Class Study, dated June 7, 2021 to: 1) Establish the following classes within the Construction Labor Compliance Series: Construction Labor Compliance Technician, Senior Construction Labor Compliance Technician; and Construction Labor Compliance Supervisor; Pursuant to Civil Service Rule 2.6(c), grant permanent status to: Johnny Lee into the proposed Labor Compliance Technician class, Rosalyn Burkes and Krystal Kypke into the proposed Senior Labor Compliance Technician class; and Harmail Nijjar into the proposed Labor Compliance Supervisor class; and 3) Refer these actions to the Board of Supervisors for its concurrence. The Motion was adopted unanimously (4 to 0).
