ADOPTED ACTION MINUTES

Acting Chair Bloise announced that due to a temporary lack of quorum, the Commission would recess until 2:05pm or until a third commissioner arrived. The meeting was reconvened at 2:20pm once a third commissioner arrived.

The Motion was adopted unanimously (3 to 0).

Executive Officer Dowdin Calvillo reported that the next Commission meeting is May 27 and Commissioners will likely consider recommendations for revisions to the County's Classification Plan stemming from the 2022 Sanitation Worker (single class, technical change only); 2021 Pathologist Assistant (single class); 2021 Water System Series; and 2021 Waste Management Systems Technician series class studies at this meeting. They will also adopt the proposed meeting schedule for the 2022-23 FY.

Tentatively scheduled for Commission consideration at the June 10 meeting are recommendations of revisions to the County's Classification Plan stemming from the 2020 Environmental Regulation and Legislative Affairs Series and the 2022 Director of Mental Health class studies. They will also hear a release from probation appeal.

Tentatively scheduled for Commission consideration at the July 15 meeting will be recommendations of revisions to the County's Classification Plan stemming from the 2020 Human Service Program series class study. Commissioners may also hear an exam disqualification appeal, and will elect officers for the next fiscal year.

Dowdin Calvillo informed Commissioners that she received two exam disqualification appeals and closed one after the Appellant withdrew his appeal. Currently, there are three release probation, one exam disqualification, and one allocation appeal pending before the Commission.

Lastly, she reported that she forwarded her preliminary comments on the Administrative Assistant to the County CEO class study to DPS this week.

Seeing no further business before the Commission, and without objection, Acting Chair Bloise adjourned the meeting at 2:37pm.
