<u>ACTION:</u> By unanimous vote of those present, granted the appeal noting that Department of Personnel Services' unintentionally abused its discretion when it too narrowly interpreted its policy when rejecting this application. The Commission suggested that Department of Personnel Services review the Personnel Series classes so that the inconsistencies in the minimum qualifications can be corrected.
