The Commission expressed strong reservations about approving the extension of Ms. Abe's (B2) provisional appointment for a second time, mentioning that the system of provisionally appointing employees is meant only to be a temporary measure. The Commission further stated that should this provisional appointee need to be extended a third time, that the Commission will likely not grant it.

**<u>ACTION</u>**: By unanimous vote of those present, extended the above mentioned provisional appointments (B1, B2, & B3) for five months and 29 days from their respective dates of expiration, or until 20 days after the eligible lists are established, whichever occurs sooner.
