**ACTION:** By unanimous vote of those present, approved the following as recommended by Department of Personnel Services in their initial report dated March 29 and their amended report dated May 8, 2012 and modified by the Commission during the public hearing:

- Revised the classes of Food Service Program Manager, Cook III, Cook II, Cook I, and Baker, inclusive of minimum qualifications;
- Retitled the Cook III class to Food Service Supervisor, the Cook II class to Senior Food Service Cook; and the Cook I class to Food Service Cook; and
- Retained and Retitled the following Eligible Lists: Cook II to Senior Food Service Cook; and Cook I to Food Service Cook.
- The Commission continued consideration of revisions to the Food Service Worker (Level I/II) class directing that the current minimum qualifications, *There are no education or experience requirements,* be retained for the revised Food Service Worker class.

The Commission agreed that Department of Personnel Services would make changes to the *knowledge* and *ability* statements in the Food Service Worker class specification as a result of the original minimum qualifications be maintained.

I. <u>CONTINUED</u>: Department Of Personnel Services Proposed Amended Revisions To The Classes Of 1) Custodial Services Manager, 2) Supervising Custodian II, 3) Supervising Custodian I, And 4) Custodian (Level I/II), Inclusive Of Revising The Minimum Qualifications For Each Class; Request To Abolish The Classes Of 5) General Service Supervisor II, 6) General Service Worker III, And 7) General Service Worker II; 8) Request To Grant Status To Study Incumbents In Accordance With Civil Service Rule 2.6 (c); And, 9) Request To Abolish The Custodian II Eligible List (Continued by Civil Service Commission on May 11, 2012)

Following discussion at the <u>May 11, 2012</u> meeting, the Commission continued its consideration of the matter directing that the second pattern Minimum Qualification for the Supervising Custodian II class be modified from *One* year to *Two* years so that it reads, *Or: 2. Two* years of *full-time, paid experience supervising the work of custodial personnel engaged in the cleaning and care of health care, commercial, industrial and/or public buildings or facilities.* 

**<u>ACTION</u>**: By unanimous vote of those present, approved as recommended by Department of Personnel Services (DPS) in their initial report dated March 5, 2001, as directed to be modified by the Commission at its May 11, 2012 meeting, and as recommended in the DPS amended request dated May 14, 2012:

- Abolished the classes of General Service Supervisor II, General Service Worker III, and General Service Worker II;
- Granted Status to Study Incumbents; and
- Abolished the Custodian II Eligible List
