The Commission convened for its regularly scheduled meeting at 1:31 p.m. on Friday, December 16, 2005, at 700 H Street, in Hearing Room 2, Suite 1445, Sacramento, California. Commissioners Johnson, Nakagawa, Bruce Nelson and Raymond Nelson were present. Commissioner Keen was absent.

B. Departmental Requests To Extend Provisional Appointments

(1) Municipal Services Agency – Jose Mendez, In The Class Of Code Enforcement Officer II

<u>ACTION</u>: By unanimous vote of those present, extended the above-mentioned provisional appointment for five months and 29 days from the date of expiration or until 20 days after the eligible list is established, whichever occurs sooner.

C. Appeals Pursuant To Civil Service Rule 4.2, Application Rejection

(1) Felicia Boissiere – Human Services Specialist

After oral presentation by Appellant, response from Employment Services representatives, and following lengthy discussion, David Devine, Department of Employment Services and Risk Management Director requested that the appeal be continued to the next Commission meeting to allow his staff additional time to review Ms. Boissiere's coursework and perhaps arrive at an administrative remedy.

<u>ACTION</u>: By unanimous vote of those present, continued without prejudice to January 20, 2006.

(2) Esther Diaz - Human Services Specialist

Chairperson Nakagawa confirmed with Appellant and Department of Employment Services and Risk Management that the issues raised by Ms. Diaz in her appeal were similar to Ms. Boissiere's. To allow time for Employment Services staff to review Ms. Diaz's coursework and perhaps arrive at an administrative remedy, the Commission continued the appeal to the meeting of January 20, 2006

H. Closed Session: Proposed Decision Of The Hearing Officer In The Matter Of The Appeal Of ... From An Order Of Disciplinary Action Of A Pay Step Reduction As An Office Assistant II (C), With Department Of Employee Records And Training

<u>ACTION:</u> At the request of the appellant, the Commission convened and acted on this matter in closed session. By the following vote the Commission adopted as the decision of the Civil Service Commission, County of Sacramento, State of California, the hearing officer's findings of fact, conclusions of law, and order denying the appeal.

J. OPEN SESSION: Discussion, Action And Direction To Commission Staff Concerning Department Of Health And Human Services Privacy Concerns Regarding Closed Session Disciplinary Appeal Information Contained In Civil Service Commission Minutes

At the request of Commissioner Johnson, discussion of this matter took place prior to the two Closed Session matters set on the agenda.

Kathleen O'Connor, Commission Counsel noted for the record that, to protect the identity of appellants, all closed session disciplinary and release from probation appeals could be introduced and the final votes announced during the open public meetings by identifying only the classification title and the disciplinary or release action being taken.

Commissioner Raymond Nelson suggested that two separate sets of minutes could be produced by staff. The public minutes would exclude appellants' names but reference that a confidential set of minutes is kept by the Commission. The confidential minutes would include appellants' names and not be released to the public. Ms. O'Connor further advised the Commission that formal permission from the Board of Supervisors would be required in order to keep separate public and confidential minutes. Commission Raymond Nelson moved to submit to the Board of Supervisors, a request to keep separate Public Civil Service Commission Minutes and Confidential Civil Service Commission Minutes in order to protect the names of appellants requesting closed session hearings on appeal before the Commission.

<u>ACTION:</u> By unanimous vote of those present, approved introducing and announcing final votes on closed session disciplinary and release from probation appeals in open session public meetings by identifying the classification title and disciplinary or release action being taken only; approved submitting to the Board of Supervisors a request to keep separate Public Minutes and Confidential Minutes of Commission meetings to protect the identity of appellants in closed session matters before the Commission.
