Department Of Personnel Services: Proposed Revisions To The Class Of Senior Mental Health Worker And Mental Health Worker, Inclusive Of Revisions To The Minimum Qualifications, And Inclusive Of Separating The Classes From The Existing Single Class Series Format Into Separate Class Specifications

ACTION: By unanimous vote, continued consideration of the revisions to the above-titled classes, as submitted by Department Of Personnel Services in their report dated April 10, 2006, to the meeting of June 9, 2006, with the following directive:

- 1. To the Senior Mental Health Worker and Mental Health Worker class specifications, add the subheading "General Qualifications" above the License Requirement section;
- 2. To the Senior Mental Health Worker and Mental Health Worker class specifications, change "these classes" to "this class" in the License Requirement paragraph.
- 3. Revise Pattern 1 of the Senior Mental Health Worker Minimum Qualifications so that it reads.

Either: 1. Two years of experience *in the class of* Mental Health Worker in Sacramento County service.

4. Revise the second sentence in Pattern 2 of the Senior Mental Health Worker Minimum Qualifications, "Or: 2. Education from an accredited college or university in a mental health related field, such as social work, rehabilitation counseling, psychology, or counseling may be substituted for up to two years for the required experience on a yearfor-year basis," so that it clearly describes the number of educational units required for substitution of the required experience.

J. Department Of Personnel Services: Proposed Revisions To The Physician Assistant Class Specifications, Inclusive Of Minimum Qualifications <u>ACTION:</u> By unanimous vote, approved revisions to the above-titled class, as submitted by Department of Personnel Services in their report dated April 10, 2006; as amended in their Correction Report dated May 18, 2006; and as recommended in the CSC Staff Report dated May 4, 2006, that page 2 of the class specifications be amended by replacing <u>Other</u> <u>Requirements</u> with <u>General Qualifications</u>.
