The Commission convened for its regularly scheduled meeting at 1:35 p.m. on Friday, June 23, 2006, at 700 H Street, in Suite 1450, Sacramento, California. Commissioners Johnson, Meredith, Nakagawa, and Bruce Nelson were present. Commissioner Raymond Nelson was absent.

Department of Health and Human Services submitted a request to extend the provisional appointment of Nicole Kahl, in the class Public Health Microbiologist Trainee, stating that an examination will not be developed because incumbents are temporary employees and may not gain permanent status in the class.

Pursuant to Civil Service Rule 5.4 (g), "Trainee to First Working Level Examination," there are a number of classes in which it is desirable to allocate the position at the first working level, employ a person in the position at the trainee level, and promote him/her in the same position when his/her training is completed and he/she is deemed competent to function at the first working level. Appendix A of the <u>Civil Service Rules</u> lists Public Health Microbiologist Trainee as a class approved for examination under Rule 5.4 (g).

On June 22, 2006, Department of Personnel Services requested that the matter be withdrawn from the agenda because Public Health Microbiologist Trainees are temporary positions and an eligible list will not be established; and reported that the trainee positions will be removed from future monthly status reports on provisional appointments submitted to the Commission.

Further discussions revealed confusion about the Public Health Microbiologist Trainee classification and DPS requested that the withdrawal be rescinded, so that the provisional appointee, Nicole Kahl, is not disadvantaged while a solution to the issue is being sought.

During the Commission meeting, DPS reiterated their request that Nicole Kahl's provisional appointment be extended, and that they will work with County Counsel in order to develop an exam for the Public Health Microbiologist Trainee class.

<u>ACTION</u>: By unanimous vote of those present, extended the above-mentioned provisional appointments for five months and 29 days from their respective dates of expiration or until 20 days after the eligible lists are established, whichever occurs sooner.
