Department Of Personnel Services And Sacramento County Airport System: Proposed Revisions To The Class Of Fire/Operations Worker (Level I/II), Inclusive Of Minimum Qualifications And Re-titling To Firefighter Aircraft Rescue And Firefighting (Level I/II); Request to Grant Status Under Rule 2.6(c)(2) To Senior Fire/Operations Worker Incumbents Reallocated To The New Class Of Firefighter Aircraft Rescue And Firefighting (Level I/II); And Request To Abolish The Senior Fire/Operations Worker Class

1. Revised the Fire/Operations Worker (Level I/II) class specifications, inclusive of Minimum Qualifications;

- 2. Re-titled the Fire/Operations Worker (Level I/II) class to Firefighter-Aircraft Rescue Firefighting (Level I/II);
- 3. Granted status to Senior Fire/Operations Worker incumbents in the Aircraft Rescue Firefighter (Level II) class;
- 4. Abolished the class of Senior Fire/Operations Worker; and
- 5. Amended the second paragraph of the revised Distinguishing Characteristics section so that it reads:

"This class is distinguished from the *Fire/Operations Supervisor* in that the latter functions as a first level supervisor responsible for supervising the activities of personnel..."

D. Department Of Personnel Services And Department Of Facility Planning, Architecture And Real Estate: Proposed Revisions To The Class Of Chief, Division Of Building Design; Inclusive Of Revising The Minimum Qualifications And Retitling To Chief, Architectural Services Division

<u>ACTION</u>: By unanimous vote of those present, approved revisions to the above titled class specifications as recommended in Department of Personnel Services November 28, 2006 report; and as recommended in the January 2, 2007 Executive Officer's Staff Report, as follows:

• The **Distinguishing Characteristics** section should be amended (underlined) to read:

The class differs from the class of Director of Facility Planning, Architecture and Real Estate in that the latter is responsible for overall coordination and management of a functional group of divisions within the Department of Facility Planning, Architecture and Real Estate, whereas the former is responsible for establishing the architectural design program – directing, development, implementing, coordinating, and evaluating programs for the Architectural Services Division.
