- 1. **Revise** the class of Recycling Coordinator, inclusive of Minimum Qualifications;
- 2. **Abolish** the Assistant Recycling Specialist (Level I), Assistant Recycling Specialist (Level II), and Associate Recycling Specialist classes; and,
- 3. Correct -
 - On the first page under **DEFINITION**, change the word "coordinates" to coordinate so that the sentence reads:

"Under direction positions in this class plan and promote recycling programs and coordinate solid waste program outreach efforts for the County of Sacramento."

 On the first page under **DISTINGUISHING CHARACTERISTICS**, change the word "performs" in the second line to perform so that it reads:

"...in that the latter classes perform professional planning work related to solid waste..."

E. Department Of Personnel Services And Municipal Services Agency: Proposed Revisions To The Class Of Solid Waste Planner, Inclusive Of Minimum Qualifications And Re-titling To Solid Waste Planner 2; Request To Establish The New Class Of Solid Waste Planner 1, And Request To Abolish The Current Solid Waste Planner Eligible List

<u>ACTION</u>: By unanimous vote of those present, approved as recommended by the Department of Personnel Services and the Municipal Services Agency March 27, 2007 report, as amended by the Executive Officer in the April 23, 2007 staff report, and as further modified by the Commission during the public hearing:

- 1. **Revise** the class of Solid Waste Planner, inclusive of Minimum Qualifications, and modifying the current 12-month probationary period to 6 months;
- 2. Re-title the class of Solid Waste Planner to Solid Waste Planner 2;
- 3. Adopt the new class of Solid Waste Planner 1;
- 4. Abolish the current Solid Waste Planner Eligible List; and,
- 5. Correct -
 - On the second page of the Solid Waste Planner 2 classification specification, under minimum qualifications, the word "year" to "years", so that it reads:

"Three years of full-time experience in solid waste facility and/or program planning activities,"

F. Department Of Personnel Services And Municipal Services Agency: Proposed Revisions To The Class Of Waste Management Program Manager, Inclusive Of Revising The Minimum Qualifications

<u>ACTION</u>: By unanimous vote of those present, approved the revisions to the above titled classes as recommended by the Department of Personnel Services and the Municipal Services Agency March 27, 2007 report, and as modified by the Commission during the public hearing:

- 1. **Remove** Under **Minimum Qualifications**, remove the language "progressively responsible" from both patterns #2 and #3, so that each reads:
 - Pattern 2: "Four years of full-time experience, with at least two years"
 - Pattern 3: "Six years of full-time experience, including at least two years"
