Department of Personnel Services And Sacramento County Airport System Revised: 1) Proposed Revisions To The Class Of Chief, Airport Fire Fighting And Airfield Operations, Inclusive of Minimum Qualifications And Re-titling To Fire Chief, Aircraft Rescue And Firefighting; 2) Proposed Revisions To The Class Of Fire Operations Supervisor, Inclusive Of Minimum Qualifications, And Re-titling To Fire Captain, Aircraft Rescue And Firefighting; 3) Proposed New Class Of Fire Battalion Chief, Aircraft Rescue and Firefighting; 4) Proposed Revisions To The Firefighter, Aircraft Rescue And Firefighting (Level I/II) Class Specification; And 5) Proposed Abolishment Of The Assistant Chief, Fire Rescue Operations Class (*Continued from 7/13/07*)

<u>ACTION</u>: By unanimous vote, approved the revisions to the above titled class specifications as recommended in Department of Personnel Services May 24, 2007, and Amended July 18, 2007 reports; and, as recommended in the Executive Officer's Staff Report and as the Commission modified during the public hearing as follows:

- 1.) *Revised* the class of Fire Operations Supervisor, inclusive of:
 - **Adding** EMT and CPR certificate requirement to internal patterns;
 - **Adding** restricted class "B" firefighter license requirement with a Tank Vehicle Endorsement; and,
 - **Re-titling** to Fire Captain, Aircraft Rescue and Firefighting
- **2.)** Adopted as a new class Fire Battalion Chief, Aircraft Rescue and Firefighting, inclusive of:
 - Adding EMT and CPR certificate requirement to internal patterns; and,
 - **Adding** restricted class "B" firefighter license requirement with a Tank Vehicle Endorsement
- **3.)** *Revised* the class of Firefighter, Aircraft Rescue and Firefighting (Level I/II), inclusive of:
 - **Adding** restricted class "B" firefighter license requirement with a Tank Vehicle Endorsement, and language requiring incumbents to possess this license within six (6) months of appointment
- 4.) <u>CONTINUED</u> (to 8/10/07) Chief, Airport Fire Fighting and Airfield Operations, in order to make revisions to the minimum qualification as directed by the Commission during the public hearing
- 5.) Abolished the class of Assistant Chief, Fire Rescue Operations

J. Valentine N. Obi: Ratification Of Withdrawal Of Appeal From Release From Probation As A Senior Wastewater Treatment Plant Operator II With The Municipal Services Agency

ACTION: By unanimous vote, ratified withdrawal of appeal.

K. David Holtz: Appeal From Disqualification For Failure To Pass The Pre-Employment Medical Examination For Probation Aide, Probation Department.
