CHIEF, CODE ENFORCEMENT DIVISION:

Correct the proposed class specification as follows:

1. On the first page, the Example of Duties section should read: **EXAMPLES OF DUTIES**

Duties may include but are not limited to the following:

- Directs and manages professional and/or technical staff engaged in various code enforcement activities.
- 2. On the third page, above the <u>Certifications Requirements</u> section, add the subheading, <u>GENERAL QUALIFICATIONS</u>.
- 3. On the fourth page under <u>Minimum Qualifications</u> remove "with major coursework" from patterns 1b, 2b and 3c, so that each sentence reads: "A 4 year degree from an accredited college or university in Criminal Justice, Sociology, Public Administration, Business Administration, Political Science, or a related field."
- 4. Remove the request to abolish the current Principal Code Enforcement Officer eligible list.

CODE ENFORCEMENT MANAGER:

Correct the proposed class specification as follows:

- On the second page, in patterns 1b and 2b under <u>Minimum Qualifications</u> remove "with major coursework" and add language specific to how many of the completed units must be in Criminal Justice, Sociology, Public Administration, Business Administration, Political Science, or related field.
- 2. Remove the request to abolish the current Code Enforcement Manager eligible list.

E. Department Of Personnel Services And Sacramento County Airport System: New Class Of Airport Operations Dispatcher (Level I/II); Revisions To The Communications/Operations Dispatcher Series Classification Specifications; And Grant Status To Study Incumbents, Pursuant To Civil Service Rule 2.6(c)
