- G. Department of Personnel Services and Department of Facility Planning, Architecture and Real Estate: 1) Proposed Revisions to the Class of Associate Real Estate Agent, Inclusive of Minimum Qualifications and Re-titling to Real Estate Officer (Level I/II); 2) Proposed New Class of Real Estate Specialist; 3) Proposed Revisions to the Real Estate Program Manager Minimum Qualifications; 4) Request to Abolish the Class of Assistant Real Estate Agent (Level I/II); and 5) Request to Grant Status to Study Incumbents in Accordance with Civil Service Rule 2.6

The Commission <u>continued</u> consideration of the following to a date to be determined by Department of Personnel Services:

- <u>Revisions</u> to the class of Associate Real Estate Agent and its re-titling to Real Estate Officer (Level I/II);
- <u>Revisions</u> to the Minimum Qualifications of the Real Estate Program Manager class;
- Abolishment of the class of Assistant Real Estate Agent (Level I/II); and,

 Granting of Status to the study incumbents identified for reallocation to the new class of Real Estate Officer.

The Commission <u>directed</u> that language be added to the Distinguishing Characteristic section of the proposed new Real Estate Officer (Level I/II) class specification, clearly identifying what minimum standards incumbents in the first salary level, Real Estate Officer (Level I) must achieve prior to advancing to next salary level of Real Estate Officer (Level II).
