<u>ACTION:</u> By unanimous vote of those present, took the following action as submitted by Department of Personnel Services in their report dated May 9, 2008:

- 2. Revised the class of Highway Maintenance Supervisor II, inclusive of Minimum Qualifications and Retitled the Highway Maintenance Supervisor II class to Highway Maintenance Supervisor;
- 3. Revised the Highway Maintenance Series Specification to reflect the current changes; and
- 4. Re-titled the Current Highway Maintenance Supervisor II Eligible List to Highway Maintenance Supervisor

The Commission did not grant status to the Highway Maintenance Supervisor I incumbents as requested as the Department of Transportation and Department of Water Resources Highway Maintenance Supervisor I incumbents were reallocated and granted permanent status as Highway Maintenance Supervisors II when the Commission granted item K on the agenda, the University Research & Associates appeal.

G. Department Of Personnel Services: Proposed New Class Of Stormwater Utility Supervisor And Request To Grant Status To Current Department Of Water Resources Highway Maintenance Supervisor I And Highway Maintenance Supervisor II Incumbents In The New Stormwater Utility Supervisor Class

<u>ACTION:</u> By unanimous vote of those present, approved as submitted by Department of Personnel Services in their report dated May 15, 2008.

- 2. Granted Status to current Department of Water Resources Highway Maintenance Manager incumbents in the new class of Stormwater Utility Manager.
- I. Department Of Personnel Services: Proposed Revision To The Airfield Maintenance Supervisor Class, Inclusive Of Minimum Qualifications, And Re-titling To Airfield Maintenance Manager

<u>ACTION:</u> By unanimous vote of those present, continued consideration of the above matter to the July 25, 2008 meeting, directing that Department of Personnel Services report back with clarification on how substantially different in job duties, functions and abilities, the Airfield Maintenance Supervisor and Airfield Maintenance Manager classifications is from the Highway Maintenance Supervisor and Highway Maintenance Manager classifications.

- J. Department of Personnel Services: Proposed New Class Of Airfield Maintenance Supervisor And Request To Grant Status To Current Sacramento County Airport System Highway Maintenance Supervisor II Incumbents In The New Airfield Maintenance Supervisor Class, In Accordance With Civil Service Rule 2.6
 - <u>ACTION:</u> By unanimous vote of those present, continued consideration to the July 25, 2008 meeting, directing that Department of Personnel Services report back with clarification on how substantially different in job duties, functions and abilities, the Airfield Maintenance Supervisor classification is from the Highway Maintenance Supervisor classification.
- K. University Research & Associates Appeal On Behalf Of Highway Maintenance Supervisor I and Highway Maintenance Supervisor II Incumbents Regarding Their Position Allocations In Department of Transportation And Department Of Water Resources

<u>ACTION:</u> By unanimous vote of those present, granted the appeal, reallocating and granting permanent status to Department of Transportation and Department of Water Resources Highway Maintenance Supervisor I incumbents as Highway Maintenance Supervisors II
