J. Department Of Personnel Services: Proposed Revisions To The Class Of Real Estate Program Manager, Inclusive Of The Minimum Qualifications

<u>ACTION:</u> By unanimous vote, approved the corrections to the Real Estate Program Manager minimum qualifications as submitted in the February 19, 2009 Department of Personnel Services report:

**1.)** Remove reference to the word *Agent* under Distinguishing Characteristics, so that it reads as below in the *first sentence in paragraph one:* 

# **DISTINGUISHING CHARACTERISTICS:**

Positions in the Real Estate Officer series are assigned to the Real Estate Division in the Department of Facility Planning, Architecture, and Real Estate.

**Remove** reference to the word *Agent* under Distinguishing Characteristics, so that it reads as below in the *last sentence in paragraph four:* 

The class is distinguished from the next lower class of Real Estate Officer (Level I/II) by the latter's lack of supervisory responsibilities and a lesser need for specialized knowledge of real estate activities.

**Correct** an to a under the Minimum Qualifications, in the first sentence under the "Or" pattern so that it reads:

Or: 2. Three years of experience in governmental, public utility or commercial real estate, performing duties at a level comparable to a Real Estate Officer (Level I/II) which have included: . . ..
