E. Department Of Personnel Services: Proposed Revisions To The Following Classes: 1) Workers' Compensation Supervisor, Inclusive Of Reducing The Probationary Period To Six Months; And Request To Grant Status To Study Incumbent Pursuant To Civil Service Rule 2.6(c); 2) Workers' Compensation Manager, Inclusive Of Revising The Minimum Qualifications; And, 3) Workers' Compensation Examiner

<u>ACTION:</u> By unanimous vote, continued consideration of revisions to the above-titled classes, as submitted in the Department Of Personnel Services March 12, 2009 report, and their April 1, 2009 Amended report, to a date to be determined.

The Commission noted that the March DPS report states "it is a business

necessity that a criminal history and/or background check be conducted on all applicants prior to appointment." However, the proposed revised class specifications for Workers' Compensation Supervisor, Workers' Compensation Manager, and Workers' Compensation Examiner each contained the Board of Supervisor approved Criminal History and Background Check language "may access."

The Commission requested clarification of the County policy regarding Criminal History and Background Checks and recommended, so candidates are correctly notified, that when it is the appointing authority's intention to always run the Criminal History and Background Checks check prior to appointment, that the language "may" be modified to "shall" in the first sentence of both paragraphs of the Criminal History and Background Checks section.

F. Department Of Personnel Services: Proposed Revisions To The Specifications Of The Dietitian Class Series, Inclusive Of Minimum Qualifications; And, Inclusive Of Reformatting Dietitian And Supervising Dietitian Into Separate Class Specifications

<u>ACTION</u>: By unanimous vote, continued consideration of revisions to the above-titled classes, as submitted in the Department Of Personnel Services (DPS) February 13, 2009 report, to a date to be determined.

The Commission noted that the DPS report stated "it is a business necessity that a criminal history and background check be conducted on all applicants prior to appointment" yet the proposed revised class specifications for Dietitian and Supervising Dietitian contained the Board of Supervisor's approved Criminal History and Background Check language "may access."

The Commission requested that DPS seek clarification of the County policy regarding Criminal History and Background Checks and recommended, so that candidates are correctly notified, that when it is the user department's intent to always run the checks prior to appointment, that the language "may" be modified to "shall" in the first sentence of both paragraphs of the Criminal History and Background Checks section.

The Commission further requested that DPS report back within thirty (30) days regarding whether the Dietitian and Supervising Dietitian eligible lists will be retained or abolished.
