<u>ACTION</u>: By unanimous vote, the Civil Service Commission approved the following as submitted by Department of Personnel Services in their initial report dated May 12, 2010; and their June 30, 2010 Amended Request; and as modified by the Commission at the June 18 and July 23, 2010 public hearings:

- 1. Revised the Senior Environmental Analyst class, inclusive of Minimum Qualifications to include the "Either: 1a. And 1b. Or: 2a. And 2b" formatting used by DPS in their May 12, 2010 report, and inclusive of retaining the current Six Month Probationary Period;
- 2. Revised the Associate Environmental Analyst class, inclusive of Minimum Qualifications to include the "Either: 1a. And 1b. Or: 2a. And 2b" formatting used by DPS in their May 12, 2010 report, and inclusive of a Twelve Month Probationary Period;
- 3. Revised the Assistant Environmental Analyst, and Environmental Technician classes, inclusive of revising the Minimum Qualifications for both classes; and,
- **4.** Abolished the Senior Environmental Analyst and Associate Environmental Analyst Eligible Lists.
- I. Department of Personnel Services Proposed Revisions To The Class Of Principal Environmental Analyst, Inclusive Of Revising The Minimum Qualifications And Request To Increase The Current Six Month Probationary Period To Twelve Months

<u>ACTION</u>: By unanimous vote, continued to a date to be determined by Department of Personnel Services directing that the Minimum Qualifications be modified to match the formatting used for the other classes in the series as submitted by DPS in their May 12, 2010 report. Following discussion, the Commission directed the following:

- Amend the Minimum Qualifications to the "Either: 1a. And 1b. Or: 2a. And 2b" formatting used by DPS in their May 12, 2010 report recommending revisions to the Senior, Associate, Assistant and Technician classes in the Environmental Analyst class series;
- **2.** <u>Amend</u> the second pattern <u>Minimum Qualification</u> by increasing the years of required experience to "Five (5)" as noted by DPS was their original intention, and by adding language similar to "and performing 1st level management work": and
- **3.** <u>Provide</u> further justification for increasing the current 6 month <u>Probationary Period</u> to twelve months.
