**D. Department Of Personnel Services Proposed New Scientist (Level I/II) Class; New Senior Scientist And Chief Scientist Classes, Both Inclusive Of Twelve Month Probationary Periods; And Request To Grant Status To Study Incumbents In Accordance With Civil Service Rule 2.6**

- **Denied** granting of status to study incumbent, Timothy Mussen in the new Scientist (Level I/II) class, directing that a competitive examination be used to fill the position.
